### "March-In" D.C.

MAG's Geri Lehnardt traveled to Washington, D.C. on March 20 & 21 to meet with members of Congress and staff to advocate for those suffering from Alzheimer's Disease. Geri met with Senator Mike Lee and shared first-hand experiences from her 25+ years of serving those with the disease and the significant increase in need for support not only in Utah, but specifically in the MAG service region.

She joined nearly 900 other Alzheimer's Advocates with the Alzheimer's Association for all 50 states to meet with congress and rally for access to treatment to help fight a disease that more than 6 million people suffer nationwide.

In 2020, an estimated 34,000 people in Utah suffered from Alzheimer's disease. That number is projected to increase by 23.5% to 42,000 sufferers in 2025. To learn more and join the fight, visit https://www.alz.org/utah.

### MAG 2023 Legislative Session Summary

The 2023 Legislative General Session was one for the books. The legislature passed a record

575 bills, approved a historic \$29.4 billion dollar budget that included \$250 million for housing, \$350 million for water, \$1.2 billion for transportation and infrastructure improvements, more than \$900 million for debt reduction and avoidance, a more than \$400 million tax reduction package, and more than \$233 million for public education. I'd say it was the year of water... housing, homelessness, education, tax reduction, and transportation. MAG is thrilled to announce that seven projects have been awarded technical assistance for cycle I of the Technical Assistance to Governments (TAG) Program. Awards fund plans and studies that integrate transportation and land use. Each project is unique to the community and their respective growth challenges and opportunities. For example, Jill Spencer, Payson City Planner, noted that their TAG Program award "comes at a critical time in the city's growth and will help the city plan for big changes in a way that complements the existing community and enhances our quality of life." #### Mark your Calendars - the Draft 2023 TransPlan50 Public Comment Period Opens April 16, 2023

MAG is seeking input about transportation in Utah County. The draft <u>2023 TransPlan50</u> <u>and Air Quality Conformity Determination</u> will be released for public comment beginning April 16, 2023.

TransPlan50 is the regional transportation plan (RTP) for urbanized Utah County. Its planned projects and programs are a coordinated system of capital-intensive roadway projects, transit improvements, and pedestrian/bicycle facilities, needed over the next thirty years. The plan attempts to minimize impacts on society and the environment while providing for enough transportation capacity and choices to ensure the region's economy

continues to grow. To stay relevant, the plan is updated every four years.

To keep up with the transportation needs for a county that will grow to 1.2 million people in 2050, the plan proposes over 280 highway, transit, and active transportation capacity projects. Limited funding, especially within the next decade, equates



to 32 unfunded road and transit projects and 115 road and transit projects not funded within the decade when the need is identified (see image).
