Description: This project includes constructing a new 3 lane minor arterial connection at 400 W on the west side of State Street with a new traffic signal. The existing 400 W corridor will be upgraded to a 3 lane arterial with 66-feet of right-of-way. The project is regionally significant because it establishes a vital grid connection, linking State Street from Lindon's 400 W to Orem's 1200 W, which terminates at University Parkway and the UVU campus. This connection is expected to alleviate traffic on alternative routes like State Street and Geneva Road.

In City's Master Plan: Adopted April 2024, <u>Transportation Master Plan</u>

Description: This project, part of the Nebo Belt Study, reconfigures Spanish Fork's 300 E as an 3 lane arterial road within city limits. It also establishes a new 3 lane arterial road through the river bottoms, linking to the Nebo Belt project and Woodland Hills Drive. This project offers the region an alternative to Spanish Fork Main Street, connecting a significant Spanish Fork retail hub near I-15 to southern Utah County communities like Salem, Woodland Hills, and Elk Ridge.
